• Save an additional 5% off the annual tuition when all fees are paid in full by August 1, 2025 (for **new enrollments**, this date is extended to **September 1, 2025**)

### **Discount Rules and Conditions**

- Multiple discounts/ATA cannot be combined.
  - •1 discount per family.
  - If the current family is on ATA discount cannot be applied to arrangement of ATA payments.

### • ECE Programs are separate from Ministry Programs. Discounts do not apply for ECE programs.

• Maintenance Hours - If 20 hours of maintenance hours are completed in 2024/2025, the \$300.00 maintenance fee will be waived for 2025/2026. If a portion of maintenance hours is completed during 2024/2025, a reduced maintenance fee for 2025/2026 will be invoiced.

### **Grades Fees Conditions:**

• **No deductions** can be made in cases of absence including sick days. Fees are payable on the first day of each month. It is understood that submission of post dated cheques or Pre–Authorized Debit request on a monthly basis is based on the annual tuition, and not based on the number of days in attendance month by month.

- Registration and interview/assessment fees are non-refundable and due by September 1, 2025
- Please note: If a family registered for the 2025-2026 school year withdraws
  - a) Before July 1, 2025 there is no penalty;
  - b) Before Aug. 1, 2025, but after July 1st, 2025 there is a one month penalty;
  - c) After Aug. 1, 2025 there is a two month penalty (not applicable for new families).

# ECE Payment Plan: Registration Deposit of \$200.00 is due with registration and is non refundable. The deposit will be applied to Sept. 2025 tuition fees.

First Payment – Due by Aug. 1, 2025 (For new enrolments, this date is extended to September 1, 2025)

 Payment includes: Registration Fee & School Supply Fee
 10 month Payment Plan Tuition: Payments Due each month from September - June.

#### **ECE Fees Conditions**

• Fees are based on monthly scheduled enrollment. **No deductions** can be made in cases of absence including sick days. Fees are payable on the first day of each month. Post-dated cheques or Pre-Authorization Debit Payment Plan are required.

• Application for child care fee subsidy is the responsibility of the parent/guardian and must be made at the local Ministry for Children and Families office. Applicable agency forms must be submitted before enrolment. Full payment is due at the start of each month. If and when subsidy funds are remitted by the Ministry, parents will be notified the amount to be deducted from their account. Subsidy only applies to actual days in attendance.

• Withdrawal requires 2 months' notice. This 2-month notice commences the first calendar day of the month following notice of withdrawal. • Modification to a student's ECE program requires 1 month notice and takes effect from the first calendar day of the following month. • The Association reserves the right to cancel any and all classes due to an insufficient number of children at any time. In such an event, Tuition and School Supply Fees will be refunded on a prorated basis
